Depart Amish Acres immediately following the performance.

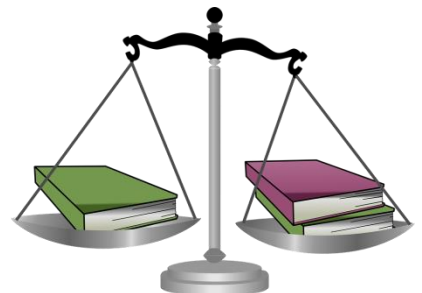
